2022 HEALTH INSURANCE

A telephone conference with Theresa Kocer-Wellmark was held. Kocer reviewed the current health insurance coverage and proposed coverage. The County coverage of reimbursement back to employees will increase from \$600 to \$700 (out of pocket maximum) per year. Motion carried.
