Jensen called for public comment. There was none.

TOWN OF ROSHOLT

Charlie Vandeputte and Keith Falken met with Commissioners and Sheriff Hillestad and discussion took place regarding Rosholt contracting with Roberts County for law enforcement. After discussion, it was decided to meet again at a later date.
MALT BEVERAGE LICENSE

The hearing for Malt Beverage license renewals and one new license was held. Gordon Nielsen in attendance. Motion by Zempel, seconded by Johnston to approve renewals for Buck's Enterprises, Dakota Connection, Cheetah's Peanut Bar, Hartford Beach, Lake Traverse Resort, Schmidt's Landing, Shady Beach, Sodak Shores, Valley View Country Club, The Wharf and With the Wind Winery and new license for Smokin' Bones. Motion carried. STATES ATTORNEY

Stickland discussed Kyle Ramsden-Modern Construction will repair the leak in the Highway shop roof.

Stickland discussed the fence around the yards that was taken down when the State installed the roundabout. After discussion, it was agreed not to install new fence due to having issues in the winter with snow.

Stickland discussed a letter to Commissioners from Ron Kohl, Mike Sebek and Norway Township allowing a ditch to be dug for draining purposes in Section 25 of Norway Township.

CASH TRANFER

Motion by Carlson, seconded by Johnston to convene into Executive Session at 11:06 pursuant to SDCL 1-25-2(1) to discuss personnel. Motion carried. Jensen declared meeting back into regular session at 11:44.

Lori Moen met with Commissioners and gave 2019 investment in Roberts County report. PURCHASE ORDER

Motion by Carlson, seconded by Zempel to approve purchase order for Director of Equalization from McLeod's for forms for \$679.80. Motion carried. RESOLUTION

Motion by Vergeldt, seconded by Johnston to adopt the following resolution-motion carried:

A RESOLUTION AMENDING RESOLUTION 2020-15 WHICH WAS PASSED TO ADDRESS A PUBLIC HEALTH CRISIS BY IMPLEMENTING CERTAIN MEASURES WHICH HAVE BEEN DEEMED NECESSARY TO SLOW THE COMMUNITY SPREAD OF CORONAVIRUS (COVID-19).

WHEREAS, the Roberts County Commission has the authority to pass Resolutions, per $SDCL\S7-8-20$ (8) and (10), for the purpose of promoting the health, safety, morals and general welfare, of the community and the promotion of health and the suppression of disease; and

WHEREAS, an outbreak of the disease COVID-19, which is caused by the novel coronavirus, has been confirmed in more than 100 countries, including the United States;

WHEREAS, COVID-19 is a severe respiratory disease transmitted by person-to-person contact, or by contact with surfaces contaminated by the virus. In some cases, especially among older adults and persons with serious underlying health conditions, COVID-19 can result in serious illness requiring hospitalization, admission to an intensive care unit, and death; and

WHEREAS, the World Health Organization (WHO), the Centers for Disease Control and Prevention (CDC), and the Secretary of the U.S. Department of Health and Human Services have declared the outbreak of COVID-19 as a public health emergency; and

WHEREAS, on March 13, 2020, the President of the United States declared a national emergency in response to the global pandemic of COVID-19; and

WHEREAS, on the same day, Governor Kristi Noem, issued Executive Order 2020-04 which declared a state of emergency to exist in the State of South Dakota in response to the spread of COVID-19; and

WHEREAS, a case of COVID-19 has been confirmed in thirty counties in South Dakota;

WHEREAS, the CDC and health experts have recommended social distancing to slow the spread of COVID-19; and

WHEREAS, social distancing is a method of slowing down or stopping the spread of a contagious disease by reducing the probability of contact between infected persons and those not infected in order to minimize disease transmission; and

WHEREAS, in response to the need to implement social distancing all schools in the state have been closed until May 1, 2020; and

WHEREAS, on March 16th, 2020, the White House issued guidance recommending that social gatherings of more than ten people be avoided and that people avoid eating or drinking at bars, restaurants, and food courts; and

WHEREAS, the guidance issued by the White House further recommended that in states with evidence of community transmission, bars, restaurants, food courts, gyms, and other indoor and outdoor venues where people congregate should be closed; and

WHEREAS, many states and communities across the country have already implemented the White House recommendations by ordering all bars, restaurants, food courts, gyms, and other indoor and outdoor venues where people congregate be closed until the public health emergency is over; and

WHEREAS, the failure to successfully implement social distancing will likely result in higher numbers of infected individuals and has the potential to overwhelm the capacity of the County's health care providers; and

WHEREAS, it is important that control measures be taken to reduce or slow down the spread of COVID-19 in order to protect the health and safety of the County's residents, especially for seniors and those with underlying health conditions that make them particularly vulnerable to COVID-19.

NOW THEREFORE, BE IT RESOLVED, by the Roberts County Commission that:

- 1. Effective at 12:01 on June 17, 2020, all Roberts County Facilities (described in number 3 below) are open to the general public.
- 2. Effective immediately, in cases when a member(s) of the public displays symptoms of COVID-19, as specified by the South Dakota Department of Health, the County offices are directed to refuse face-to-face/in person service and encourage the individual(s) to seek medical attention as specified by public health authorities.
- 3. All restaurants, bars, wineries, clubs, cafes and other similar places of public accommodation offering food or beverages for on-site consumption, including any alcohol licensees with on-sale privileges, may be open to on-site/on-sale patrons

and may continue to operate to provide take-out, delivery, curbside service, drive-thru service. All recreational facilities/music or entertainment venues, hookah lounges, cigar bars, vaping lounges or other similar business, arcades, bingo halls, bowling alleys, skating rinks and other similar recreational or entertainment facilities may be open. Any business open to the public should implement procedures to ensure social distancing. Businesses should operate at 50% capacity and operate in compliance with federal and state health guidance in order to prevent the spread of COVID-19.

- 4. The prohibitions and closures in this order do not apply to the following businesses:
 - a. Places of public accommodation that offer food and beverages for off-site consumption, including grocery stores, markets, retail stores that offer food, convenience stores, pharmacies, drug stores, and food pantries, other than any portion of such business which would be subject to the requirements of paragraph #1.
 - b. Room service in hotels.
 - C. Health care facilities, residential care facilities, congregate care facilities, and correctional facilities.
 - d. Crisis shelters, homeless shelters, soup kitchens, or other similar institutions.
 - e. Airport concessionaires.
 - f. Any emergency facilities necessary for the response to the current public health emergency or any other community emergency or disaster.
 - g. Any Incorporated municipality; they are self-regulated.
- 5. This Resolution shall remain in effect until such time as it is amended or repealed.
- 6. Any violation of this Resolution is subject to the general penalty provision in SDCL 7-18A-32. Each day a violation of this Resolution is allowed to occur is considered a separate offense.

BE IT FURTHER RESOLVED, that this resolution is necessary for the immediate preservation of public peace, health, safety, and welfare of Roberts County and shall become effective immediately on June 17, 2020.
