Appel also discussed hiring a part time deputy and another full-time school resource/patrol deputy. The sheriff department has been awarded another \$125,000 grant to be used over the next 3 years for a resource officer. No decisions made today. HIGHWAY

Stickland discussed the two applications for bridge improvement grant (BIG) funds he'd received from the SD DOT.
